

“FIJI + VEGAS SWEEPSTAKES” OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

THIS SWEEPSTAKES IS INTENDED FOR THOSE WHO QUALIFY IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ONLY, EXCEPT WHERE PROHIBITED BY LAW, AND WILL BE GOVERNED BY NEVADA LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND NOT LOCATED IN THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA AT THE TIME OF ENTRY.

ENTRY PERIOD: “FIJI + VEGAS SWEEPSTAKES” (“Sweepstakes”) starts at 12:00:01 p.m. (PST) on July 20, 2010 and ends at 11:59:59 a.m. (PST) on August 20, 2010 (collectively the “Entry Period”). Sponsor’s computer is the official time-keeping device for the Sweepstakes.

HOW TO ENTER: Between 12:00:01 p.m. (PST) on July 20, 2010 and ends at 11:59:59 a.m. (PST) on August 20, 2010, visit www.mirage.com/fijisweepstakes and follow the directions provided therein to enter any required information, and submit. All entries must be received by 11:59 a.m. (PST) on August 20, 2010 to be eligible. Limit one entry per person and per e-mail address for the entire Entry Period. No purchase necessary. Entries received from any person or e-mail address in excess of the stated limitation will be void.
